West Nile Virus — Update for 2003

ichigan has been very fortunate this year relative to transfusion-transmitted West Nile Virus (WNV) infections and also WNV infections in general. As of October 15, 2003, there were 6,957 CDC-reported WNV cases in the United States but only four cases in the State of Michigan. The infections have moved further west this year, and the five leading states are Colorado (2200 cases), Nebraska (1100 cases), South Dakota (900 cases), Texas (400 cases) and North Dakota (375 cases). There is no explanation for the lack of cases in Michigan and why WNV cases have moved to the West. The death rate for the CDC-reported cases is approximately 2%. Thirty to 40% of the CDC-reported cases developed meningo-encephalitis and 60-70% developed the much milder WNV fever. Assuming that there are approximately 150-200 unreported WNV cases for every severe case reported to the CDC, then it is possible that approximately 600,000 persons in the U.S. have been infected with WNV as of October 15th.

American Red Cross, SE Michigan Region has detected four WNV-viremic blood donors so far via nucleic acid testing, and these units were destroyed. There have been no reports of WNV-transfusion-transmitted cases in the Detroit metropolitan area from local hospitals as of

October 24, 2003. Nationwide, by the end of September, two transfusion-transmitted cases were detected in the West. These cases were missed by pooled testing but were detected by single donor testing. Preliminary data suggest that 16-unit pooled testing (Chiron/Gen-Probe) detects approximately 85% of the positive cases and another 15% could be detected if single donor testing was done. Single donor testing has been done in very high risk areas, but it quickly absorbs all resources, and it is not feasible past a limited scope.

As of the end of September, 510 WNV-viremic blood donors had been reported to the CDC by U.S. blood centers. All donors were feeling well when they donated blood. Eighty-five percent never developed any symptoms around the donation time, 14% developed mild symptoms (WNV fever), and 1% developed meningoencephalitis.

In all, we have been very fortunate in the State of Michigan this year with very few CDC-reported cases in the State and no known transfusion-transmitted cases in the Detroit metropolitan area. The new nucleic acid test for WNV appears to be very effective, and it has greatly helped to keep WNV out of the blood supply.
